IN THE MATTER OF LICENSE NO. 24210 ISSUED TO JERRI DANG VO, DDS

NON-DISCIPLINARY REMEDIAL PLAN

On February 26, 2016, this Remedial Plan was issued by the Texas State Board of Dental Examiners (Board) to resolve the above-referenced matter. This Remedial Plan is issued under the authority of Tex. Occ. Code § 263.0077 and based on the allegation that violations of the laws or rules regulating the practice of dentistry have occurred.

Allegations

Based on an investigation, Board staff alleged that Jerri Dang Vo, DDS (Respondent) failed to make and maintain adequate dental records with respect to two patients, as required by 22 Tex. Admin. Code §§ 108.7(1) (eff. to Sept. 2014), 108.8. The record deficiencies include no initial medical history, written review of medical history, vital signs, findings and charting of clinical and radiographic oral examination, diagnoses, a treatment plan including recommendations and treatment options, documentation of treatment provided, medication and dosages given, lab prescriptions, and signed written informed consent.

Requirements

1. Within sixty (60) days of the date of issuance of this Remedial Plan by the Board, Respondent SHALL provide proof to the Compliance Division of the Board of the successful completion of three (3) hours of pre-approved continuing education courses in the area of Risk Management and Record Keeping. Courses that are not pre-approved are presumed insufficient.
2. Within sixty (60) days of the date of issuance of this Remedial Plan by the Board, Respondent SHALL remit a five hundred dollar (\$500.00) check or money order to the Board to recover the costs of administering this Remedial Plan.
3. Failure to comply with the requirements of this Remedial Plan may result in disciplinary action against Respondent's license.

Acknowledgement

I, Jerri Dang Vo, DDS, have read and understand the foregoing Remedial Plan, and I agree to its requirements. I neither admit nor deny the allegations made in this Remedial Plan. I voluntarily waive my right to a formal adjudicatory hearing to contest this matter, and I acknowledge that this Remedial Plan is final and non-appealable.




